












Seasoned Singles






chinese & golden ministry staff



Central Christian Church (CCC) is built on a strong belief to emulate Jesus in helping the poor and needy. Together with HOPE worldwide Singapore (HOPEwwS), our community outreach arm, we relentlessly serve the local community through impactful volunteerism.

We gave out 250 sets of lunch boxes and drinks, and took time to survey the residents to understand their needs and how else we can help them with the support from COMNET Senior Activity Centre.







HR Management

The staff remuneration is set and approved by the Committee.

Our remuneration consists of fixed remunerations and performance-linked bonus.

Performance appraisals are done yearly to ensure that employees receive performance feedback and to set objectives for the new work year.

Reserves Policy

The Church has a Reserves policy for long-term stability of the operations and it ensures that there are sufficient resources to support the charity Church in the event of unforeseen circumstances. The Reserves level is reviewed yearly by the Board to ensure that the Reserves are adequate to fulfil the Church's continuing obligations.

Conflict of Interest Policy

All Board members and staff are required to comply with the Church's conflict of interest policy.

The Board has put in place documented procedures for Board members and staff to declare actual or potential conflicts of interests on a regular and need-to basis.

Board members also abstain and do not participate in decision-making on matters where they have a conflict of interest.

Donations to External Parties & Mission Support

Donations to other charities are conducted out of a spirit to help orphans, widows and other less fortunate persons.

Permitted by the Consitution, donation to other charitable organizations may be decided by the Committee.

The Church provides financial mission support to her overseas sister churches under the SEA Region umbrella.

These are conducted out of a spirit to propagate the Christian religion.

The Committee approved the donations to charities and mission support to churches.

The Church is aware and is supportive including making trips to visit the charitable organizatons and overseas sister churches.

Fundraising Activities

The Church held a private fundraising event from 25 June 2022 to 24 July 2022. The funds were for the Malaysia churches in Seremban and Kuching mission support. \$93,500 was raised. The Church has kept its fund-raising efficiency ratio below 30%, in compliance with the requirements for all Charity and IPCs in Singapore.

NOTES TO THE FINANCIAL STATEMENTS FOR THE FINANCIAL YEAR ENDED 31 DECEMBER 2022

These notes form an integral part of and should be read in conjunction with the accompanying financial

General information

Central Christian Church ("the Church") operates in the Republic of Singapore. The address of its registered office and principal place of business is located at 1 Edgefield Walk, Singapore 828850.

The Church is registered as a charity organisation under Charities Act 1994 (the "Charities Act") on 08 November 1989 and is registered under the Societies Act 1966 on 22 January 1988.

The principal activities of the Church are to function as a church in the propagation of the Christian faith and to operate a childcare centre.

Significant accounting policies

2.1 Basis of preparation

The financial statements have been prepared in accordance with Charities Accounting Standard ("CAS") and the disclosure requirements of the Societies Act 1966 and Charities Act 1994. The financial statements have been prepared under the historical cost convention, except as disclosed in the accounting policies below

These financial statements are presented in Singapore Dollar ("S\$"), which is the Church's functional currency.

The preparation of these financial statements in conformity with CAS requires management to exercise its judgement in the process of applying the Church's accounting policies. It also requires the use of certain critical accounting estimates and assumptions. The areas involving a higher degree of judgement or complexity, or areas where estimates and assumptions are significant to the financial statements are disclosed in Note 3.

2.2 Income recognition

Income is included in the statement of financial activities when the following three factors are

- The Church becomes entitled to the income;
- · The governing Management Committee members is virtually certain that they will receive
- The monetary value can be measured with sufficient reliability.

2.2.1 Contributions and other income

Contributions are recognised are recognised upon receipts.

2.2.2 Childcare fee income

Childcare fee income is recognised over the period of instruction and service provided. Childcare fee income for qualifying children are partially subsidised by the Early Childhood Development Agency ("ECDA"). Childcare fee income and the subsidy claims received are separately disclosed.

2.2 Income recognition (Cont'd)

2.2.3 ECDA subsidy claims

ECDA subsidy claims are recognised when there is reasonable assurance that the subsidy will be received, and all attaching conditions will be complied with.

2.2.4 Interest income

Interest income is recognised using the effective interest method.

2.2.5 Other income

Other income is recognised when received.

2.3 Government grants

Government grants are recognised as income in the financial statements over the periods necessary to match them with the related costs, which they are intended to compensate, on a systematic basis. Government grants related to assets after recognition will then be reduced over the useful life of the asset in line with its depreciation.

2.4 Expenditure recognition

Expenditure are recognised in the statement of financial activities once the goods or services have been delivered or rendered. Expenditure in the statement of financial activities are classified under the cost of charitable activities and governance costs.

Charitable activities

Expenditure on charitable activities comprises all costs incurred in undertaking work to meet the charitable objects of the Church. Such costs include the direct costs of the charitable activities of the Church together with those support costs incurred that enable these activities to be undertaken. All resources applied in undertaking activities to meet the Church's charitable objectives are classified under cost of charitable activities.

Governance and administrative expenses

Governance costs include the costs of governance arrangement, which relate to the general running of the Church as opposed to the direct management functions inherent in generating funds, service delivery and programme or project work. Governance costs will normally include both direct costs such as internal and external audit, legal advice for the Church and costs associated with constitutional and statutory requirements, and related support costs which where material, would comprise apportionment of shared and indirect costs involved in supporting the governance activities.

2.5 Employee benefits

2.5.1 Defined contribution plans

Defined contribution plans are post-employment benefit plans under which the Church pays fixed contributions into separate entities such as the Central Provident Fund ("CPF"), on a mandatory, contractual or voluntary basis. The Church has no further payment obligations once the contribution has been paid. The Church's contribution to defined contribution plans are recognised as employee compensation expenses when they are

2.5.2 Short-term employee benefits

Short-term employee benefit obligations are measured on an undiscounted basis and are expensed as the related service is provided. A liability is recognised for the amount expected to be paid if the Church has a present legal or constructive obligation to pay this amount as a result of past service provided by the employee, and the obligation can be estimated reliably.

2.6 Financial assets

2.6.1 Recognition and measurement

Receivables, excluding prepayments, are initially recognised at their transaction price, excluding transaction costs, if any. Transaction costs are recognised as expenditure in the statement of financial activities as incurred. Prepayments are initially recognised at the amount paid in advance for the economic resources expected to be received in the future.

Receivables and investments in financial assets are subsequently measured at cost less accumulated impairment losses.

2.6.2 Derecognition

Financial assets are derecognised when the rights to receive cash flows from the financial assets have expired or have been transferred and the Church has transferred substantially all risks and rewards of ownership.

2.6.3 Impairment

The Church assesses at each reporting date whether there is objective evidence that a financial asset or a group of financial assets is impaired.

An allowance for impairment of other receivables is recognised when there is objective evidence that the Church will not be able to collect all amounts due according to the original terms of the receivables. Significant financial difficulties of the debtor, probability that the debtor will enter bankruptcy or financial reorganisation, and default or delinquency in payments are considered indicators that the receivable is impaired. The amount of the allowance is the difference between the asset's carrying amount and the present value of estimated future cash flows, discounted at the original effective interest rate. The amount of the allowance for impairment is recognised in the statement of financial activities within "Governance and administrative costs".

Subsequently, if the amount of an impairment loss decreases and the decrease can be related objectively to an event occurring after the impairment was recognised, the previously recognised impairment loss will be reversed. The reversal will not result in any carrying amount of the financial asset (net of any allowance account) that exceeds what the carrying amount would have been had the impairment not previously been recognised. The amount of reversal is recognised in the statement of financial activities.

2.7 Property, plant and equipment

2.7.1 Measurement

All property, plant and equipment are stated at cost less accumulated depreciation. All items of property, plant and equipment are initially recorded at cost. Fully depreciated assets still in use are retained in the financial statements.

The cost of an item of property, plant and equipment is recognised as an asset if, and only if:

- It is probable that future economic benefits associated with the item will flow to the Church; and
- · The cost of the item can be measured reliably.

The cost of an item of property, plant and equipment comprises all of the following:

- a) Its purchase price, including legal and brokerage fees, import duties and nonrefundable purchase taxes, after deducting trade discounts and rebates;
- Any costs directly attributable to bringing the asset to the location and condition necessary for it to be capable of operating in the manner intended by management.
 These can include the costs of site preparation, initial delivery and handling, installation and assembly, and testing of functionality; and
- c) The initial estimate of the costs of dismantling and removing the item and restoring the site on which it is located, the obligation for which the Church incurs either when the item is acquired or as a consequence of having used the item during a particular period for purposes other than to produce inventories during the period.

Property, plant and equipment are not revalued and are not required to be assessed for impairment under CAS.

2.7.2 Depreciation

Depreciation on property, plant and equipment is calculated using the straight-line method to allocate their depreciable amounts over their estimated useful lives as follows:

Useful lives Leasehold land 29 years Church building Remaining lease period Computers 2 - 5 years Sound system 5 years Office equipment years Furniture and fittings 5 years LCD projector 5 years Office equipment 5 years Renovation 5 years

The residual values, estimated useful lives and depreciation method of property, plant and equipment are reviewed and adjusted as appropriate, at each reporting date and, where necessary, revised to reflect changes in expectation.

Fully depreciated assets are retained in the financial statements until they are no longer in use.

2.7.3 Subsequent expenditure

Subsequent expenditure relating to plant and equipment that has already been recognised is added to the carrying amount of the asset only when it is probable that future economic benefits associated with the item will flow to the Church and the cost of the item can be measured reliably. All other repair and maintenance expenses are recognised in the statement of financial activities when incurred.

2.7.4 Disposal

An item of property, plant and equipment is derecognised upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss on derecognition of the asset is recognised in the statement of financial activities in the year the asset is derecognised.

2.8 Cash and cash equivalents

Cash and cash equivalents include cash on hand, and deposits with financial institutions which are stated at cost.

2.9 Financial liabilities

Financial liabilities are recognised when the Church becomes a party to the contractual agreements of the instrument and are classified according to the substance of the contractual arrangements entered into. All interest related charges are recognised in the statement of financial activities. Financial liabilities includes "Other payables".

Financial liabilities which are due to be settled within 12 months after the reporting date are presented as current liabilities in the statement of financial position even though the original term was for a period longer than 12 months and an agreement to refinance, or to reschedule payments, on a long-term basis is completed after the reporting date and before the financial statements are authorised for issue. Other financial liabilities due to be settled more than 12 months after the reporting date are presented as non-current liabilities in the statement of financial position.

Financial liabilities are derecognised when the obligations under the liability are discharged or cancelled or expired. When existing financial liabilities are replaced by another from the same lender on substantially different terms of an existing liability are substantially modified, such an exchange or modification is treated as a derecognition of the original liability and the recognition of a new liability, and the difference in respective carrying amounts is recognised in the statement of financial activities.

2.10 Other payables

Other payables, excluding accruals, are recognised at their transaction price, excluding transaction costs, if any, both at initial recognition and at subsequent measurement. Transaction costs are recognised as expenditure in the statement of financial activities as incurred. Accruals are recognised at the best estimate of the amount payable.

2.11 Funds accounting

Monies received for specific purposes, including transfers from the general fund, are credited directly to the respective fund in the financial statements. These include restricted funds and unrestricted funds. Unrestricted funds are expendable at the discretion of the Church Committee in furtherance of the Church's objects.

Income and expenditure relating to specific funds are accounted for directly in the funds to which they relate. Common expenses, if any, are allocated on a reasonable basis to the funds based on the method suitable to this common expense. Assets and liabilities of the specific funds are pooled in the statement of financial position.

Funds received for specific purposes such as purchase of depreciable assets are taken to the relevant restricted fund account. This relevant fund will be reduced over the useful life of the asset in line with its depreciation. Depreciation is charged to the relevant designated funds where the asset is held.

2.12 Contingencies

Contingent liabilities are not recognised in the financial statements. They are disclosed unless the possibility of an outflow of resources embodying economic benefits is remote. Where the possibility of an outflow of resources is not remote, the Church discloses for each class of contingent liability at the reporting date, a brief description of the nature of the contingent liability and, where practicable:

-) an estimate of its financial effect;
- b) an indication of the uncertainties relating to the amount or timing of any outflow; and
- c) the possibility of any reimbursement.

A contingent asset is not recognised in the financial statements but disclosed when an inflow of economic benefit is probable.

2.13 Events after the reporting period

Post year-end events that provide additional information about the Church's position at the reporting date (adjusting events) are reflected in the financial statements. Post year-end events that are not adjusting events are disclosed in the notes to the financial statements when material.

Critical accounting estimates, assumptions and judgements

Estimates, assumptions and judgements are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

3.1 Critical accounting estimates and assumptions

The Church makes estimates and assumptions concerning the future. The resulting accounting estimates will, by definition, seldom equal the related actual results. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are discussed below.

3.1.1 Useful lives of plant and equipment

Management determines the estimated useful lives and the related depreciation for its plant and equipment based on the period over which the plant and equipment are expected to provide economic benefits. Management's estimation of the useful lives of plant and equipment is based on collective assessment of industry practice, internal technical evaluation and experience with similar assets.

The estimation of the useful lives of the plant and equipment could change significantly due to physical wear and tear, technical or commercial obsolesce and legal or other limits on the use of plant and equipment. The depreciation charge is increased where useful lives are less than previously estimated lives.

The carrying value of plant and equipment as of 31 December 2022 and 2021 are disclosed

Based on Management's assessment, no change in the estimated useful lives of property, plant and equipment is required as of 31 December 2022 and 2021.

3.2 Critical judgements in applying the entity's accounting policies

The key critical judgement in applying the entity's accounting policies concerning the future at the reporting date, that has a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, is discussed below.

3.2.1 Government grants

Government grants to meet operating expenses are recognised as income in the statement of financial activities on the accrual basis in the year these operating expenses were incurred and there is reasonable assurance that the Church will comply with the conditions

For certain grants, the government agencies reserve the right to withdraw, withhold or reduce the amount of any funds approved but not yet disbursed or to call for the refund of all funds which have been disbursed to the Church if the conditions are not met.

For the years ended 31 December 2022 and 2021, the management assessed the Church has met the conditions attached to the grants.
